Pipe Lines Q & A: Q. This month Pipe Line asks ...

Has the County engineering study of the new Stock Island wastewater vacuum system been completed...and if so, what are the results of the report?

H. Yes, the County commissioned URS, a nationally known engineering firm to perform a present usage and 20-year projected analysis of the vacuum wastewater collection system and technology being installed on Stock Island by KWRU. The results were reported to the County Commission on November 29th and here is the story...

URS completes engineering study of the KWRU vacuum system, report confirms sufficient capacity and lowest expense...

On Nov. 29th URS, a national engineering firm contracted by the Monroe County Board of County Commissioners (BOCC) reported on their completed engineering analysis of the KW Resort Utilities vacuum collection wastewater system.

URS reported: "The (KWRU)) vacuum collection system appears to have sufficient capacity to continue to support wastewater collection efforts in (Stock Island) throughout the 20-year planning horizon."

The URS Report also found that the vacuum collection system designed by Weiler Engineering and installed by KWRU had the lowest installation and operational cost as compared to other sewer system options for Stock Island.

Results of the analysis confirm that the existing vacuum collection system should be capable to handle the current and future wastewater flows for south Stock Island and is the most cost efficient.

BOCC gives URS Report 5 thumbs up with unanimous vote, directs county staff to create hook-up plan...

The 5-0 vote of the Monroe BOCC to accept the findings of the URS Report was final action remaining to continue the major task of connecting the residences and businesses of south Stock Island to the new vacuum collection sewer system.

The BOCC also directed staff to create a sewer system connection plan for Stock Island. All of the Florida Keys are under a State mandate to connect all households and businesses to a central sewer system with advanced wastewater treatment by 2010.

This is necessary to help clean and protect the near shore waters as well as the fish and wildlife environment of the Keys.

SI property owners with a central collection wastewater system capped at the property line will receive County notice...

South Stock Island property owners not connected to the central wastewater system will receive a letter of notification in the beginning of 2005 from the County Code Enforcement and the Health

Department to connect their property to the wastewater system.
